What year was FLIR incorporated and in what state?

FLIR was incorporated in 1978 in Oregon.

When did FLIR Systems go public and at what price?

FLIR's IPO was June 22, 1993. \$1.63 was FLIR's opening price.

Where is FLIR's stock traded?

FLIR is traded on the NASDAQ Global Select National Market under the symbol "FLIR".

How can I invest in FLIR?

FLIR does not have a direct stock purchase plan. FLIR's common stock can be purchased or sold through a stockbroker or financial institution that offers brokerage services.

Does FLIR pay a cash dividend?

FLIR awarded a qualified cash dividend to our common stock holders of \$0.1200 per share on February 19, 2016. Future dividends will be assessed on a quarterly basis, and there are no guarantees for future dividends.

FLIR had three 1:2 stock splits: 05/29/2003, 02/02/2005 and 12/10/2007.

What is FLIR’s fiscal year?

January 1 – December 31.
